Additional comments and recommendations

Accommodation and meal arrangements were provided by each country independently, supervised by the coaches and teachers of each participating country/club. Athletes were accommodated in different units. We have no further information on the quality of services. We can confirm that they were physically, mentally and emotionally fit on the day of the competition and on the accommodation days.

In conclusion, the evaluation report of the World Cup "ROM GYM TROPHY" - Aerobic Gymnastics highlights the importance of prioritizing safeguarding aspects in sports competitions. The efforts made by the Romanian Gymnastics Federation to ensure a safe and protected environment for all participants were evident and appreciated.

By implementing strict measures to supervise and protect athletes, as well as training staff and coaches in safeguarding, the Romanian Gymnastics Federation has demonstrated its fundamental commitment to the well-being of athletes.

Also, it is gratifying that the athletes showed a high level of respect, fair play and mutual support throughout the competition, with the Ukrainian athlete, Anastasia Kurashvili, even receiving a fair play award at the end of the competition.

This highlights the importance of education in safeguarding, which must be present not only during training but also during competitions.

However, the report identifies some areas for improvement in future competitions. Better communication and coordination between federation officials, coaches, parents and athletes is recommended to ensure understanding and compliance with all safeguarding policies and regulations. Special attention should also be given to ensuring adequate and safe facilities for training and competition.

Finally, the evaluation report underlines the importance of continuous efforts in the field of safeguarding in Romanian Gymnastics. Through the implementation of the recommendations mentioned and the joint commitment of all parties involved, we can ensure a safe and secure sport environment that promotes the harmonious development and sport performance of young athlets.
